



LIABILITY WAIVER AND RELEASE

To the fullest extent allowed by law, and in consideration for being allowed to participate in **Envoy’s 2024 Aviation Day Celebration** and redeem certain prizes, including the opportunity to access and use a flight simulator located on the premises of Avenger Flight Group, LLC (“**Avenger**”) at **228 Valley View Lane Suite 180, Irving, TX** (the “**Contest Activities**”), I, on behalf of myself and my past, present, and future heirs, beneficiaries, executors, trustees, agents, representatives, attorneys, successors, and assigns, if any, hereby fully and forever **RELEASE, DISCHARGE, AND HOLD HARMLESS** Envoy Air Inc. (“**Envoy**”) and its past, present, and future officers, directors, board members, owners, employees, vendors (including Avenger) volunteers, sponsors, invitees, licensees, affiliates, agents, representatives, attorneys, successors, and assigns, if any (the “**Released Parties**”), from any and all claims, causes of action, demands, suits, losses, damages, penalties, liabilities, debts, liens, and remedies of any kind or nature (including but not limited to personal injury claims, wrongful death claims, attorneys’ fees, expenses, costs of court, interest, and equitable relief), whether at law or in equity, known or unknown, liquidated or unliquidated, fixed or contingent, or asserted or not asserted (each, a “**Loss**”), arising out of or in any way relating to any accident, injury, or death suffered by myself, or any damage to my property, in connection with my participation in the Contest Activities, use of the flight simulator, getting into or out of the flight simulator, or travel to or from the premises where the flight simulator is located, whether occurring on or off Avenger’s premises, and whether or not caused by any defect in such premises or by any other condition known or unknown to the Released Parties (regardless of any legal obligation of premises owners to inspect, prevent, or warn about any such defects or conditions). **THIS RELEASE APPLIES WHETHER OR NOT THE ACCIDENT, INJURY, DEATH, OR DAMAGE WAS CAUSED BY OR ALLEGED TO BE CAUSED BY THE NEGLIGENCE OF ONE OR MORE OF THE RELEASED PARTIES. I FURTHER HEREBY AGREE TO BE FULLY LIABLE TO THE RELEASED PARTIES FOR, AND TO FULLY INDEMNIFY AND HOLD HARMLESS THE RELEASED PARTIES FOR, ANY LOSS THEY MAY SUFFER ARISING OUT OF THE LOSS OF, DAMAGE TO OR DESTRUCTION OF ANY PROPERTY WHATSOEVER OF ANY RELEASED PARTY (INCLUDING THE FLIGHT SIMULATOR), THAT IS CAUSED BY ME.** This release may not be modified, amended, or supplemented except in writing signed on behalf of Envoy. This release is governed by Texas law.
